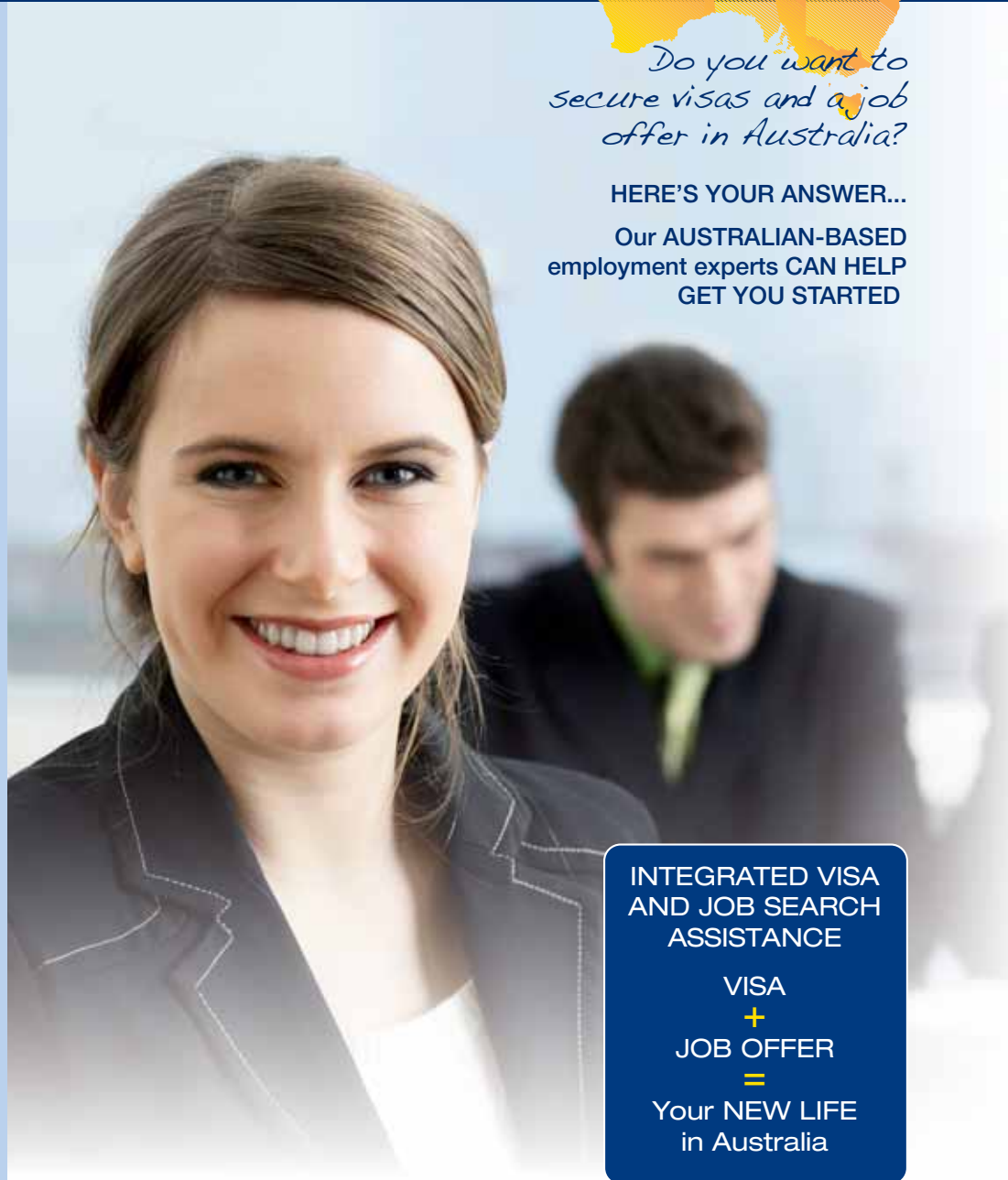

Who can use this programme?

This programme is open **EXCLUSIVELY** to full **MIGRATION BUREAU** and **VISA CENTRE** clients.

To qualify, you **MUST** be eligible for permanent residence visas (we will assess and advise you) and be using the paid services of the Migration Bureau or Visa Centre to apply for your visas. The job search component of the programme is **FREE** and open to **ONE PERSON** per application for one time use only.

About us?

The programme is operated by the Migration Bureau and Visa Centre which are part of one of the largest and longest-established international immigration consulting groups with a success rate of over 98.5% visa approvals. We have teamed up with our sister employment consulting company, ODG Recruitment, to offer you access to our highly-effective integrated visa and job search programme. ODG Recruitment has Australian-based employment experts who know the local employment market and current job opportunities, and are available to help you search for job leads inside Australia.

How does it work?

The programme is designed to get you started with your job search but it is not a total solution.

You must be actively involved at every stage of the process but we will provide you with **FREE** guidance and assistance which can help you to find a job in Australia more quickly. The Visa Centre and Migration Bureau will assist and process your residence visa application and co-ordinate your entire residency case and visa timetable for entering Australia. Once your residence visas have been approved, you can speak to the ODG Recruitment employment expert in Australia prior to departure for advice and guidance. You will have the reassurance of a personal or telephone consultation on arrival in Australia and you will then be provided with employment leads. Although it is a free service and no guarantees of success are given, past clients have found it to be highly useful and successful at linking them to job leads.



STEP-BY-STEP GUIDANCE

We will:

- Commence job search assistance only six weeks prior to a start date AND a visit or your permanent arrival in Australia for interview (very important as employers work at short notice). Research and identify employers and recruitment agents in your chosen destination that employ/place candidates with your skills.
- Provide a list of contact details of employers and recruitment agents for you to contact.
- Guide you on how to present and prepare yourself for an interview.
- Guide you on how to prepare a CV in the local style used in your destination country.
- Provide a personal or telephone job search consultation upon arrival and advice on how to set up interviews.
- Provide advice about the local job market in your chosen profession.

You will need to:

- Advise us of the specific region/city in which you have chosen to settle.
- Liaise directly with employers and recruitment agents that we may recommend in order to set up interviews.
- Be actively involved in the job search process, sending letters of applications to employers and agents that we may recommend.
- Prepare an up-to-date and comprehensive CV in the style used in your destination country for us to check.
- Plan a visit to attend interviews as most employers will not offer jobs on a "sight unseen" basis (if you require/need a job offer prior to migrating).
- Apply for vacancies no earlier than six weeks ahead of your intended arrival and a possible start date.
- Keep an open mind and be flexible. Don't expect a job at the same level or salary as in your home country. You may need to take a step back in order to gain local knowledge and experience.

How much does it cost?

The Jobseeker component of the programme is COMPLETELY FREE for one person per application. You will only need to pay all the fees associated with obtaining your visa - for example, Government and other visa application-related fees, and the migration agent fees charged by the Visa Centre or Migration Bureau. A full written quotation will be provided before you go ahead. You will also be responsible for your own flight costs, your own relocation costs and any other personal costs.



Jobseeker Programme Explained...

What are the steps to follow?

There are 4 stages to the free Jobseeker Programme and you are entitled to a maximum of two hours free consultation time with our in-country Employment Expert. This will incorporate the following stages:

1.

FIRST STAGE

Planning and Update Telephone Consultation

You will receive an initial 15-minute planning and update consultation with our in-country Employment Expert which will include:

- Advice on your C.V./Resume to ensure that it is prepared according to the local format
- An update on the local employment market
- Helpful tips on how to look for a job and the job search process
- Advice on the best time to start the job search/interview process
- Answers to any questions you may have at this time

Once registered, we will arrange for our in-country Employment Expert to phone you directly.

In addition to this service, we encourage all clients to also use other job vacancy websites and to apply directly to employers themselves. We simply want you to find a job.

As this is a free service, it is strictly limited to a total of 2 hours professional consulting time for current paying clients of the Visa Centre and Migration Bureau only. It is open to ONE PERSON per visa application for use once only. If used correctly, this service is highly-effective at getting you started with your job search provided that you are actively involved.

SECOND STAGE

Access to our Online Job Seeker Resource Board

You will receive the password to our protected JOB SEEKER RESOURCE BOARD.

This website resource will provide examples of how to prepare a locally-styled C.V., links to local job vacancy websites, links to employers and recruitment agencies and also helpful tips on the do's and don'ts when searching for work from abroad.

THIRD STAGE

(available only 6 weeks prior to a visit)

Immediate Job Vacancies and Employment Leads

Once your visas have been approved or you are visiting your destination country to attend job interviews, our in-country Employment Expert will arrange a further telephone consultation with you.

Following this consultation, we will provide you with one list of job vacancies and/or employer/recruitment agent contacts relevant to your occupation and from the region in which you wish to settle. We will also provide a list of the top internet job boards for you to search for any further relevant job vacancies.

You receive assistance at this stage once only.

For this stage, we recommend that you contact us 6 weeks prior to your intended move/visit date.

FOURTH STAGE *(upon arrival)*

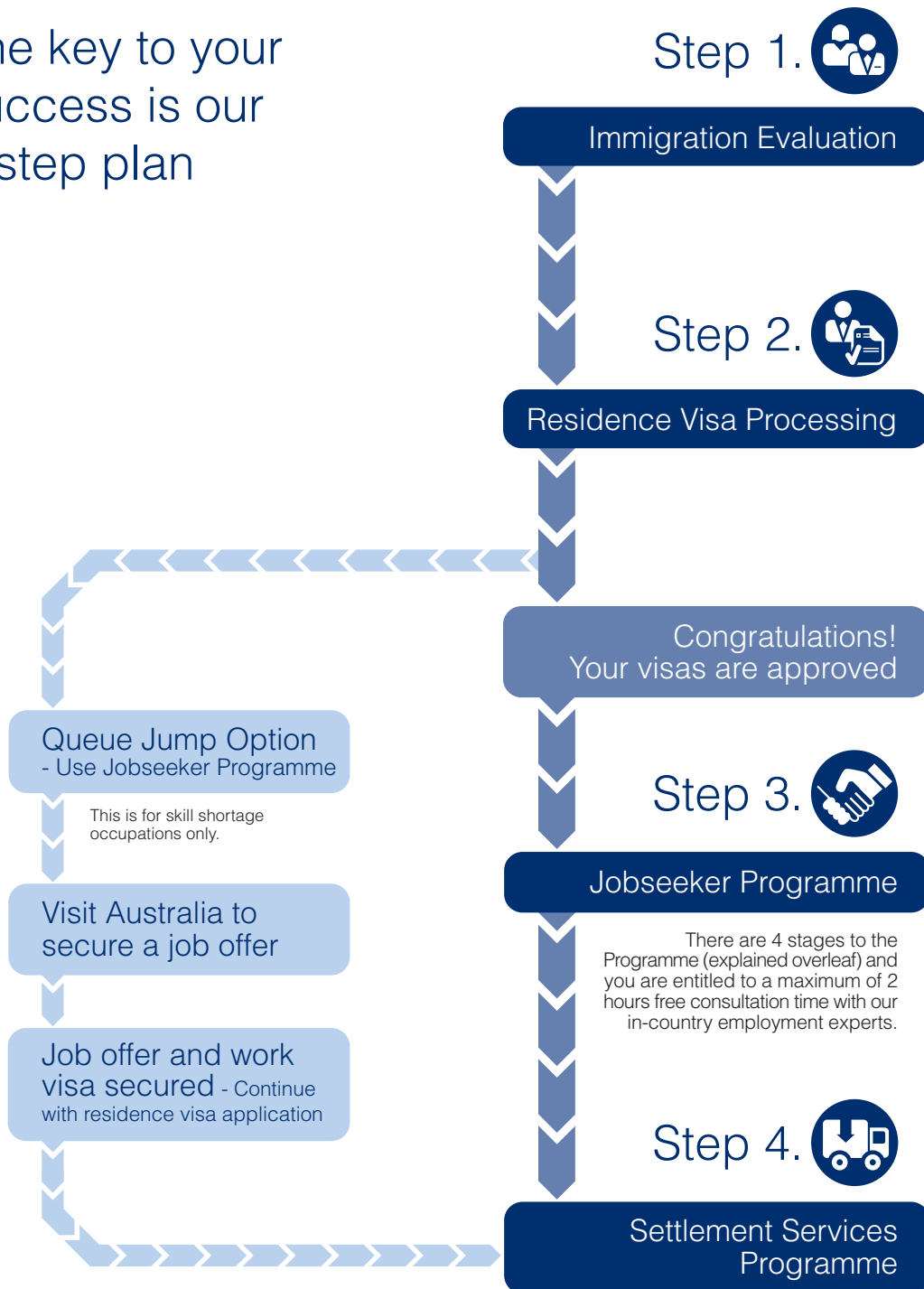
Personal or Telephone Orientation Consultation

Upon your arrival to your new destination, you are entitled to a 45 minute personal or telephone "job search orientation" consultation with our in-country Employment Expert. They are available to answer any questions you may have. You will be provided with up-to-the-minute information on the local job market and helpful job search/interview tips. You will also be provided with further current job vacancies or the contact details of local relevant employers or recruitment agents. You will then need to contact and follow-up on these leads. Our experts will also provide some initial arrival support. This consultation can be conducted in person or over the telephone/email (note only one orientation consultation is provided).

Our in-country Employment Experts will access your job prospects and advise if you qualify for the Queue-Jump Option. This can only occur once you are already applying for permanent residence visas through the Migration Bureau or Visa Centre as the condition of the local job market changes constantly and your immigration status greatly influences your employability. If accepted and successful under this option, you may be able to enter Australia more quickly on a temporary work visa.

To qualify, you MUST be working in a skill shortage occupation. The reason for this is that this pathway has a lower likelihood of success than the main job seeker programme and requires much more work and effort on your behalf. You must locate an employer that will not only issue a relevant job offer, but WILL also provide sponsorship and wait for your work visas to be issued. The work visa must also pass an official labour market test. Many Australian employers are not willing to consider such candidates unless they are experiencing pronounced shortages of your skill set. Our in-country Employment Experts will advise you if this is realistic in your case.

Entry to this option is strictly limited.

To qualify, you must:

- qualify for permanent residence visas (we will check this for you),
- be applying for permanent residence visas through the Visa Centre or Migration Bureau,
- be willing to take a visit to Australia to arrange/attend job interviews during your annual leave (2 - 3 week stay recommended),

- already possess professional registration or industry licensing if you are in a regulated occupation/profession and qualification recognition,
- have a good likelihood of being able to secure a qualifying job offer in Australia that will satisfy official labour market testing (we will advise you if this is a realistic option, as it changes regularly depending on economic conditions),
- be able to start work quickly in Australia (within 1 to 3 months),
- be accepted in writing on this option by our in-country Employment Expert,
- be willing to accept the lower likelihood of success and all the costs associated with this option.

If you meet the above criteria, then please contact us and, if accepted, provide your travel dates. Our local employment expert will then help you with employment leads. You will need to follow our instructions and actively phone and arrange/attend interviews yourself directly with employers and recruitment agents. No guarantees of success can be given as it is you, the candidate that must convince an employer that you are right for the job - but we will make sure that you have the right information and leads.

Once a qualifying job offer has been secured, the Migration Bureau and Visa Centre will help you to obtain a "bridging" temporary work visa so that you can commence work by the agreed start date. Where possible, we will take steps to expedite your permanent residence visa application so that you obtain ultimate goal of permanent residence status without unnecessary delay.
